

AMENDMENT OF
DECLARATION OF RESTRICTIONS
AFFECTING
ORCHARD GRASS HILLS SUBDIVISION
Section 1 & 2

WITNESSETH: That WHEREAS, JACK L. FARLEY CONSTR. CO. INC. is the owner of the following described property in Oldham County, Kentucky, viz:

A tract of land subdivided into a subdivision and known as ORCHARD GRASS HILLS SUBDIVISION, Sections 1 & 2, plats of which are recorded Plat Book 2, Page 51 & 52 in the Oldham County Clerk's Office, Oldham County, Kentucky.

WHEREAS, the above named corporation is the owner of the property shown on plat of ORCHARD GRASS HILLS SUBDIVISION, Sections 1 and 2, referred to on said plat as "open space" and,

WHEREAS, JACK L. FARLEY CONSTR. CO., INC. has heretofore imposed certain restrictions upon said property hereinabove described which are of record in Book 126, Page 601 in the Office of the Clerk of the County Court of Oldham County, Kentucky, and,

WHEREAS, JACK L. FARLEY CONSTR. CO. INC. desires to amend said restrictions, and,

NOW, THEREFORE, JACK L. FARLEY CONSTR. CO., INC. does hereby amend said restrictions as follows:

1. Paragraph 6 is amended to read as follows:

"The exterior building material of all structures to be erected shall be either brick, frame, stone, aluminum or combination of same."

2. Paragraphs 1, 2, 3, 4, 5, 7, 8, 9, 10, 11, 12, 13, 14, and 15, shall remain in force and effect unless amended above.
