ATTORNEY'S REPORT

The City Attorney presented the second reading of ORDINANCE NO. 2014-3, AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF ALL REAL PROPERTY WITHIN THE CORPORATE LIMITS OF ORCHARD GRASS HILLS, KENTUCKY, AND THE LEVYING OF AN AD VALOREM TAX THEREON FOR CITY PURPOSES. **Connie made a Motion to approve the ordinance. The City Attorney presented the second reading of ORDINANCE NO. 2014-4, AN ORDINANCE APPROPRIATING CERTAIN AMOUNTS OF MONEY FOR THE GENERAL OPERATING PURPOSES OF THE CAPITAL EXPENDITURES FOR THE CITY OF ORCHARD GRASS HILLS FOR THE FISCAL YEAR JULY 1, 2014 THROUGH JUNE 30, 2015. **Susan Marcum made a motion to accept the ordinance. Connie Kirchner seconded the Motion. The Motion passed.**

The Mayor presented a **Statement of Commitment to Participate in the KIPDA Multi-Jurisdictional Hazard Mitigation Planning Effort**. Scott Pierce **made a Motion** to participate in the KIPDA Multi-Jurisdictional Hazard Mitigation Planning Effort. Bob McCue **seconded the Motion**. **The Motion passed** and the statement was signed by Mayor Lalli.

Mr. Loyd of Mid-America Fireworks requested a Non-Conforming Usage Permit to see fireworks in the City of Orchard Grass Hills.
