### ENGINEER'S REPORT

City Engineer reported he did some surveying on a section of Autumn Bent where drainage affects West Orchard Grass. The best solution from W. Orchard Grass to the end of the older section is to create a small paved V ditch along both sides of the road like the ones on the end of Sideoats. This is the less expensive solution to three recurrent drainage problems, and requires 3 driveway aprons to be repaired.

Second problem to repair is at 7407 W. Orchard Grass where the sides of the yard with railroad ties are caving in from drainage issues.

### NEW BUSINESS

The city council voted to renew the Non-Conforming Use Permit for Roger Loyd, from MAD Firework for the sale of fireworks for a period of time from June 18, 2016 to July 5, 2016.
